



UNACADEMY ALL INDIA TEST SERIES - IIT JEE ADVANCED 2023

TERMS AND CONDITIONS

SORTING HAT TECHNOLOGIES PRIVATE LIMITED (hereinafter referred to as "**Unacademy**") has created and formulated an all-India test series program ("**UAITS**") that will provide the participants of UAITS (referred to as "**you**" "**your(s)**" or "**Participant(s)**") a ranking and analysis on national level and helps in evaluation of their preparation for the upcoming competitive examination including IIT JEE Mains/Advanced ("**Exam**") and also to recognise and reward such Participants who have secured top ranks in Exam. Unacademy UAITS Terms and Conditions as detailed hereunder ("**UAITS Terms**") and Platform Terms govern the relationship between you and Unacademy. All capitalized terms not defined herein shall have the meaning assigned to it under the Platform Terms. Unacademy shall from time to time communicate contest-specific terms and conditions that shall also be binding on the Participants ("**UAITS Specific Terms**"). The Platform Terms, UAITS Terms and any other UAITS Specific Terms shall collectively be referred to as "Terms and Conditions" or "Program Terms".

For the purpose of these Terms and Conditions, "**Platform Terms**" shall collectively mean and include Unacademy Terms and Conditions, Privacy Policy and any other policies and guidelines made available on www.unacademy.com and/or the Unacademy Apps (referred to as "**Unacademy Platform**"), to the extent applicable. The Participant(s) agree and acknowledge that UAITS can be hosted on a platform owned or operated by a third party. In such cases, the Participants will be bound by applicable terms and conditions and privacy policies of relevant third party.

Registration is the first step for appearing for UAITS. Accordingly, by registering for UAITS, you hereby agree to have read, understood and bound by all the Terms and Conditions that govern your participation. Hence, we strongly advise you to thoroughly read and understand the eligibility criteria for participation in the Tests and the remaining terms and conditions specified hereinunder along with the Platform Terms before proceeding with registering for the Tests. **If you do not meet the eligibility criteria or if any of the terms and conditions are not acceptable to you, then you may not proceed with your participation in the Tests.**

These Terms and Conditions are an electronic record in terms of the Information Technology Act, 2000 and applicable rules and other such applicable laws and regulations applicable to electronic records, as introduced/amended from time to time. These Terms and Conditions form a legally binding agreement between you and Unacademy in respect of your participation in UAITS. By clicking on the 'I agree' icon or by submitting the registration form for participating in UAITS, you hereby unconditionally consent, agree, and undertake to be bound by and adhere to the Terms and Conditions. The Terms and Conditions are subject to modification by Unacademy, shall continue to subsist until completion of UAITS as determined by Unacademy at its sole discretion, and hence, these Terms and Conditions shall continue to apply on the Participants for such duration.

A. Eligibility and Enrolment

Students of class 11, 12 and those who have dropped to attempt the official Exams shall be eligible to enrol as a Participant in UAITS. The individuals participating in UAITS must have proof of the same. In order to be a Participants in UAITS, the Participants must also conform to the following eligibility criteria (unless specified otherwise) in addition to the eligibility criteria in UAITS Specific Terms:

1. an Individual;
2. an Indian citizen;
3. based within the territory of India;
4. legally eligible to enter into a contract;

Participants understand that to confirm their eligibility they may be required to submit scanned copies of their admit card or registration card for the competitive Exams, application number, date of birth and any other information that may be requested by Unacademy at the time of registration or later and that the information they have submitted shall be used by Unacademy to check and verify the exam results of the Participants, once it is published.

UAITS are open to participation by individuals only. Corporate entities, agencies and any non-human legal entities are barred from participating in UAITS. The enrolment / registration process shall be as set out hereunder.

1. To participate in UAITS, the Participants will be required to follow the registration process that shall be communicated to them either via email sent by Unacademy and/or shall be provided on Unacademy Platform and register for UAITS in accordance thereof, as may be applicable. All sign-up/registration forms must be submitted directly by the Participants and where the Participants do not fulfil the Age Requirements, then such sign-ups/registrations should be done with the consent of and under the supervision of their parent or legal guardian in accordance with the Platform Terms.
2. The Participants may be required to pay a participation or enrolment fee applicable to the UAITS subscription model opted by the Participant in order to take part in UAITS, the details of which shall be as specified in UAITS Specific Terms at the time of registration ("**Enrolment Fee**"). Enrolment Fees once paid shall not be refunded in any circumstance whatsoever. All registered Learners of the Unacademy Platform of IIT JEE category who hold active Paid Subscriptions (*defined below*) shall be eligible to participate in UAITS for free. It is hereby clarified that paid subscriptions shall include (i) Plus/Iconic subscriptions and (ii) Unacademy Centre Subscriptions, (collectively "**Paid Subscriptions**"). Such Learners shall be able to access the Login Portal using their existing login credentials. Once the Enrolment Fee is paid and registration form is filled, Participant will be able to login using credentials created at the time of registration or provided by Unacademy where details related to UAITS including but not limited to no. of UAITS, date, timing, duration of each UAITS, scores, solutions, ranks can be viewed ("**Login Portal**"). The Participants will be able to take the exam using the same Login Portal. Unacademy, at its sole discretion, may revise and update the schedule of the UAITS.

3. The validity of subscription model of UAITS will be specified in UAITS Specific Terms and can be viewed at the time of purchase of UAITS subscription.

Participants are not bound in any way to participate in UAITS. Any participation is voluntary, and UAITS is being made available purely on a best effort basis. Unacademy, in its sole discretion, reserves the right to disqualify any Participant from the benefits and Rewards of UAITS, if any fraudulent activity is detected or on any breach of the Terms and Conditions by the Participant.

B. Participation

1. UAITS will be hosted online on such platform that are either owned or operated by Unacademy or any third party authorised by Unacademy. Each UAITS may or may not be a proctored test wherein Unacademy or such third parties authorised by Unacademy will be monitoring and supervising the students while taking UAITS by taking pictures or recording videos only for the sole purpose of preventing any unethical means and protecting the integrity of such exams.
2. Post payment of Enrolment Fee and completion of registration process on the Login Portal, the Participant will be able to participate in such UAITS which are scheduled 24 hours after completion of the registration process.
3. The Participants will be able to see a detailed UAITS schedule on the Login Portal and accordingly, can take the UAITS as per the schedule to be eligible for AIR, Voucher Prizes and Rewards. However, the question paper and solutions of a test will be available on the Login Portal in a pdf format after completion of an UAITS for practising offline. Participant will only be able to take one attempt of the scheduled UAITS at the scheduled date and time. The no. of UAITS, date, timing and pattern of UAITS may change at the sole discretion of Unacademy.

Pursuant to Participants submitting the sign-up/registration forms or logging-in, the information we collected therefrom may be used for various purposes of UAITS and the Unacademy Platform, including to check and verify the exam results of the Participants, reach out to them, offer rewards, etc. After the Exam results are published, Unacademy, after checking and verifying the results of the participants, shall reach out to selected rank holders through email and/or phone call. Selected Participants may be entitled to be featured as a 'rank-holder' on Unacademy Platform, rewards detailed hereinunder and recognition by Unacademy, at its sole discretion.

C. Ranking, Prizes and Score

Participants will be scored ranks at national level (“**AIR**”) that will help you to measure your level of preparation for the Exam. Top 10 rankers of each UAITS will be eligible to receive vouchers worth upto INR 2500 (Indian Rupees Two Thousand Five Hundred) (“**Voucher Prizes**”). The criteria for winning Voucher Prizes are as follows.

The ranking, and score will be in accordance with the following terms and conditions:

1. AIRs along with a detailed test analysis, scores and solutions of an UAITS will be displayed immediately after completion of an UAITS at the scheduled date and time on the Login Portal provided the Participant has taken the UAITS at the scheduled time of an UAITS. Scores and AIR displayed on the Login Portal for any UAITS shall be final and binding and will not be subject to any review.
2. The Participants shall be required to claim the Voucher Prizes on or before 30 (thirty) days from the date of credit of the Voucher Prizes. The Participants will be required to provide such information as may be requested by Unacademy, for verification of the Participants and enabling the distribution of the Voucher Prizes.
3. The Voucher Prizes shall be subject to such other terms and conditions detailed hereinunder and as may be determined by Unacademy at its sole discretion, from time to time.

Each model of UAITS shall have its own specific terms and conditions, ranking and rewards system as specified in the UAITS Specific Terms and on the registration page.

Unacademy reserves the right at its sole discretion to modify, withdraw, suspend, extend, add reschedule or cancel UAITS or the Voucher Prizes under UAITS at any time without any prior written notice.

The shortlisted Participants may be contacted and be required to submit additional information / documentation as may be essential for Unacademy to provision the Voucher Prizes. Unacademy does not accept any responsibility for any incorrect and/or incomplete communication details provided and/or delay in receipt of communication and/or non-receipt of communication.

Finally, upon collection and verification of the required documentation (as required), Voucher Prizes shall be processed to the shortlisted Participants within timeline as maybe determined by Unacademy at its sole discretion.

The process of selection, number of Participants shortlisted for the Voucher Prizes and the type or form of Voucher Prizes are to be determined, and shall be subject to change, at the sole discretion of Unacademy and the decision of Unacademy shall be final and binding. The Participants are encouraged to check the Terms on a periodic basis to ensure that they do not miss out on any updates and modifications.

D. Rewards of IIT JEE Advances 2023

After the Exam results are published, Unacademy, after checking and verifying the results of the participants, shall reach out to selected rank holders through email and/or phone call. Selected Participants may be entitled to be featured as a 'rank-holder' on Unacademy Platform. In addition to the recognition, the Participants achieving high rank in IIT JEE Advanced 2023 will also be eligible to win Rewards (defined hereinunder) in accordance with the terms and conditions detailed below.

Selection of Participant(s) for Rewards:

1. The Rewards are only applicable for IIT JEE Advanced 2023.

2. Upon the results of the Exam(s) being published, Unacademy shall check the results of the Participants who have registered for UAITS using the details they have provided at the time of registration, to determine the ranks of the Participants in such Exam(s).
3. Subject to the selection parameters and criteria for giving the rewards (“**Selection Parameters**”), the Participant(s) shall be entitled to some rewards (“**Shortlisted Participant**”); the Selection Parameters and the applicable rewards (“**Rewards**”) and the Reward Criteria are in **Annexure A**. Participants agree to carefully review the Selection Parameters which form part of UAITS Terms to understand their eligibility for being considered for the Rewards.

Please note –

1. It is important that the Participants meet all the eligibility criteria specified above and satisfy the Selection Parameters to be considered for a Reward.
2. Shortlisted Participants shall be intimated as per the contact details given by them in their applications; the intimation will be shared via email, telephonic call, or other means as deemed fit by Unacademy, after the participants have been shortlisted in accordance with the Selection Parameters.
3. Unacademy does not accept any responsibility for any incorrect and/or incomplete communication details provided and/or delay in receipt of communication and/or non-receipt of communication.
4. The process of selection, Selection Parameters, number of Participants shortlisted for the Rewards and the type or form of Reward are subject to change at the sole discretion of Unacademy and the decision of Unacademy shall be final and binding. The Participants are encouraged to check the Program Terms and the Platform Terms on a periodic basis to ensure that they do not miss out on any updates and modifications.

Process after selection:

1. The Shortlisted Participants shall be contacted through email and/phone by Unacademy.
2. Shortlisted Participants may be required to submit their Permanent Account Number (PAN) or such other equivalent identification, bank account details and such other Know Your Customer (“**KYC**”) documentation as may be essential for Unacademy to provision the Rewards.
3. Finally, upon collection and verification of the required KYC documentation (as required), Rewards shall be processed to the Shortlisted Participants within such time period specified in the Selection Parameters for each exam.

E. Personal Information

- (1) A Participant’s Personal Information, including Sensitive Personal Information, that may be collected either by Unacademy or a third party authorised by Unacademy to enable UAITS, provide ancillary services related to UAITS and delivery of the Voucher Prizes or the Rewards, shall be collected, processed, and stored in accordance with the Unacademy’s Privacy Policy. Participants shall have all the rights available to them under the applicable Data Protection Laws (*as defined in the Privacy Policy*) in accordance with the Unacademy Privacy Policy.

Unacademy shall use a Participant’s Personal Information for facilitating UAITS and rendering

the Services with respect to the Unacademy Platform in the most effective manner, to secure the Unacademy Platform and make improvements, to perform market research and product analysis, to carry out Unacademy's obligations towards the Participant, and to communicate with the Participant. The said communication can either be by calls, text, or emails and for the purposes of conducting the UAITS itself, transactional, service, advertising or promotional calls or messages about the UAITS and other offers, new products or services made available by Unacademy and the Participant hereby consents to the same. Any deletion request received from a Participant in respect of their Personal Information shall be processed in accordance with Unacademy Privacy Policy. Notwithstanding the foregoing, it must be noted that –

1. no Participant shall continue to be eligible for UAITS and/or any Voucher Prizes or Rewards associated therewith if such Participant requests for deletion of their information before the Exam results are published; and
2. if a Shortlisted Participant, after receiving the Voucher Prizes or Reward, places a request for deletion of their information submitted during registration/withdraws consent for the use of their name, photograph, and results of the exam in accordance with the Program Terms and Conditions, Unacademy shall comply with such request as per the terms of the Platform's Privacy Policy, subject to the said Participant refunding/returning the Voucher Prizes and Reward received by such Participant pursuant to these Program Terms and Conditions.
3. Subject to section (F) below, Personal Information of the Participants including their name, photograph and results of their Exam may be retained and used by Unacademy pursuant to Participants' consent to these Program Terms, during the Reward Period (*defined in Annexure A*), unless the consent is withdrawn by/a deletion request has been made by a Participant in accordance with section 2 above.

Notwithstanding the foregoing, in the event a Participant has already received a Voucher Prize or the Reward prior to a deletion request / withdrawing consent for use of its information, Unacademy shall comply with such request as per the terms of the Privacy Policy, subject to the said Participant refunding/returning the reward received by such Participant pursuant to these Program Terms.

F. Consent And Waiver by Participants

The Participant hereby consents to the use by Unacademy of his/her name, age, photograph, videos, voice recordings, rank in Exams, statements and/or testimonials ("**Personal Attributes**") for the purpose of publication, advertising, promotion on its online / offline platforms, including but not limited to the Unacademy Platform, and through any mode, medium, platform and/or format, including without limitation, in newspapers, magazines, other print media, on television, radio, internet and other electronic and/or in mailings for educational awareness.

Any testimonial or statements provided by the Participant and any other details pertaining to UAITS, the Voucher Prizes or the Rewards they have won, their use of the Platform, content available on the Platform, shall be exclusively provided to Unacademy and the Participant warrants to that extent.

Any marketing material created by Unacademy using a Participant's Personal Attributes shall remain the sole property of Unacademy, and the Participant shall have no claim of any nature against the same. The Participant understands that the use of his/her Personal Attributes by Unacademy shall be made at its sole discretion without any further notice to the Participant. Unacademy shall have no obligation to consider Participant's inputs or feedback on the use of his/her Personal Attributes.

The Participant shall release, waive, and discharge claims of any kind or nature arising out of or relating to the use of his/her Personal Attributes against Unacademy or any person or firm authorized by Unacademy to publish the same in accordance with the terms hereof. Such release, waiver and discharge shall also extend to all group companies, affiliated companies, subsidiaries, shareholders, directors, officers, employees, agents and assigns of Unacademy and any publishers of the Personal Attributes in accordance with the terms hereof. Such a release shall be binding on the Participant, his/her respective successors, heirs, assigns, executors, administrators, spouse and next of kin.

The Participant hereby confirms that the AIRs which will help them in evaluation of their preparation for Exam and the chance provided by Unacademy to be recognized for the purposes of the Voucher Prizes and Rewards, if any, in accordance with the Terms and Conditions, is sufficient consideration for the use of Participant's Personal Attributes by Unacademy in accordance with the terms hereof, and Unacademy shall have no liability to pay any consideration for any use of the Participant's Personal Attributes in accordance with the Terms and Conditions.

G. General Terms and Conditions

Information that is available on the official UAITS registration page, Login Portal or communicated on Unacademy's official social media handles shall be the only authentic and valid information with respect to UAITS. Unacademy shall not be responsible for any incorrect/misleading information relating to UAITS, presented/ displayed on any other source other than UAITS page shall not be liable for any loss suffered by any Participants based on the representation, Terms and Conditions, the information presented/displayed on any other source other than communicated by Unacademy including link shared by Unacademy or Login Portal.

After the results are announced, Unacademy may conduct a thorough evaluation to determine if the Participants have conducted themselves in accordance with the Terms and Conditions.

If at any point in time it is brought to the attention or knowledge of Unacademy that the Participant have engaged in any unethical practices including but not limited to having prior access to the questions in UAITS, usage of any circumventing technology to manipulate the product algorithm or any act which will give the Participant an unfair advantage over other Participants, engaged in any form of mal-practice, Unacademy may at its sole discretion cancel or modify any Voucher Prizes or the Reward or AIR of the Participant and bar the Participant for using any product or services offered by Unacademy.

All Voucher Prizes and Rewards are subject to the Participants adhering to the Terms and Conditions and shall be subject to the laws of India, including all the applicable tax laws.

Unacademy has endeavoured to make all reasonably practicable arrangements to minimize communication system difficulties or any other technical issues but can make no guarantee thereof and shall not be liable for any failures in the same. Unacademy shall not be responsible and/or liable in any manner whatsoever in case the Participant is unable to participate due any technical issues or due to the issues with their internet provider, hardware, facility provider, etc.

Any Participant found participating in UAITS through multiple accounts or in the event any person impersonates a Participant, such Participant(s) shall be disqualified immediately and shall not be

entitled to any Voucher Prizes or Rewards. The Participant can be barred from participating in any future UAITS, tests etc. at the sole discretion of Unacademy.

Any Participant taking part in UAITS and is declared eligible for Voucher Prizes and Rewards by Unacademy and is unable to fulfil any one or more eligibility requirements, as specified in the Terms and Conditions shall be disqualified from receiving any Voucher Prizes or the Reward. Any communication, clarification, query, dispute in this regard by the Participant, or any of the legal heirs/guardians of the Participant in any manner shall not be entertained by Unacademy.

Unacademy will not be responsible, in case anyone is unable to participate in UAITS on account of not having access to UAITS.

Participant/s winning the Voucher Prizes and Reward/s shall be contacted by Unacademy via email or any other mode of communication. Unacademy shall not be liable for any loss, claim, damage, expenses whether expressed, implied, real, or consequential incurred by the Participant due to participation, non-participation or otherwise in UAITS. Unacademy shall not be liable for any loss that occurs during the dispatch of the Voucher Prizes or the Reward to the Participant's address. Unacademy shall not be responsible for paying any applicable taxes, fee, charges, etc. related to the Voucher Prizes or the Reward.

Any query regarding UAITS will be entertained only for 1 (one) month from date of the participation in UAITS. Post such timeframe, Unacademy will not entertain any correspondence or communication regarding UAITS from any person.

Unacademy shall have the sole discretion to discontinue / cancel UAITs or any part thereof at any point in time and the Participant shall not raise any claim due to such discontinuation or cancellation at any time whatsoever.

Unacademy shall not be held responsible in case of a server shutdown or loss of Participants’ registration and/or other data. Unacademy shall not be responsible for any delay in receipt or non-receipt or incomplete or corrupt receipt of the registration or, other details of the Participant. Unacademy shall not be responsible for any technical difficulties or data corruption that may arise during the registration process. Further, Unacademy shall not be responsible and/or liable in any manner whatsoever in case the Participant is unable to register for participation in UAITs due to failure on part of the internet service provider, facility provider, etc.

Other Terms and Conditions

A Participant understands and agrees as follows-

1. The registration does not guarantee the selection and/or participation of the Participant in UAITs for Voucher Prizes or the Rewards and such selection including the selection criteria /process shall always be as per the sole discretion of Unacademy. Unacademy shall not entertain any questions, correspondence, or inquiries on the manner of conduct /evaluation and/or selection criteria non-selection of the application and/or the selection of any other Participant in respect of UAITs from any person /party whatsoever. For any clarification regarding the Selection Parameters for Voucher Prizes or the Rewards, the Participants may refer to the selection process detailed herein.
2. The Participant understands that obtaining a high rank in the competitive exam does not automatically qualify a Participant for Rewards or Voucher Prizes under UAITs and shortlisting of Participants is based on Selection Parameters as mentioned in this Terms and Conditions.

3. Unacademy shall be well within its rights to reject/disqualify the Participant or choose/announce another Participant in place of the originally Shortlisted Participant, if:
 - a. the documents or details provided by the Participant are invalid/incorrect/incomplete/misleading /untrue or not acceptable in the opinion of Unacademy; and/or
 - b. the Participant has not conformed to any of the terms and conditions contained herein; and/or
 - c. the Participant does not sign the consent form or any other documents required, if any, by Unacademy concerning UAITS.
4. It is the sole responsibility of the Participant(s) to check the Platform frequently to keep himself/herself aware of any recent changes in respect of UAITS or the Platform.
5. The Participant shall at no time communicate to any third person or the media or give any interviews on his/her participation in UAITS without the prior written consent of Unacademy.
6. The Participant shall ensure that any photos, videos, statements, comments, and/or remarks made by the Participant regarding UAITS or their participation therein, in any public domain, including their social media accounts, are not obscene, vulgar, defaming, derogatory or objectionable, denigrating women or children, hurting religious sentiments, depicting violence or shall not infringe the rights of a third person and shall not infringe copyright, right of privacy or any other rights whatsoever of any person nor violate any applicable Indian or international laws, statutes.
7. The Participant shall be solely responsible to obtain all necessary permissions, licenses, approvals, etc., as may be required prior to registering for UAITS. Further, any third-party claims/objections, if any, received regarding the Participant's participation in UAITS, shall be solely resolved by the Participant without involving Unacademy in any manner whatsoever.
8. If the Participant is found to be in violation of any of the terms and conditions contained herein and as communicated by Unacademy from time to time, or if it comes to the knowledge of Unacademy that the details submitted by the Participant during the registration are invalid/incorrect/untrue, then Unacademy may immediately disqualify the Participant from the selection process or UAITS. The Participant shall solely remain liable for any action (criminal/civil) arising therefrom.

Annexure A

SELECTION PARAMETERS AND CRITERIA FOR REWARDS
